SUBJECT: ZERO WASTE LA FRANCHISE SYSTEM RIGHTS AND RESTRICTIONS

Effective 2014 the City of Los Angeles implemented Zero Waste LA, which includes a franchised system for the hauling and disposal of commercial waste. Contracts for those haulers who received a franchise ("Franchise Service Providers" or "FSP") were executed in January 2017 and are currently in force.

Beginning July 1, 2017, all commercial waste accounts in the City of Los Angeles will start transitioning to the Franchise System Providers. LA Sanitation is responsible for administering the Franchise System.

THE FOLLOWING INFORMATION IS EFFECTIVE IMMEDIATELY UNLESS OTHERWISE STATED:

RIGHTS OF FSPs:

- In their awarded zones, only FSPs have the right to provide service to and/or contract with all commercial and multifamily customers, except multifamily customers currently receiving refuse collection service from the City.
- In their awarded zones, only FSPs have the right to solicit commercial and multifamily customers, except multifamily customers currently receiving refuse collection service from the City.

RESTRICTIONS ON NON-FSP HAULERS:

- Non-FSP haulers may no longer solicit accounts for services contracted to the FSPs under the Franchise System, including temporary bin services.
- As of August 1, 2017, the issuance of a permit to non-FSP haulers shall not grant non-FSP haulers the right to collect from customers designated as Franchise System customers, unless alternative arrangements have been made with FSPs in the appropriate zones.

EXEMPTIONS FROM THE FRANCHISE:

The Zero Waste LA Franchise System does NOT apply to the collection of the specialty materials listed below. These specialty materials may be collected by a hauler that is permitted to operate within the City of Los Angeles.

- Medical Waste
- Hazardous Waste
- Electronic Waste
- Radioactive Waste
- Pharmaceutical Waste
- Construction and Demolition (C&D) Waste
- Specialty Waste, such as biosolids; fats, oils, and grease (FOG)
- On-location Filming Waste
- Recyclables if sold as a commodity to hauler or donated


